Rental Fees

Our club offers 11 unique spaces for your event including an expansive brick courtyard and a 2-story interior venue. Use of all spaces provides ample room for up to 350 guests. The Main Dining Room can seat up to 80 guests with additional seating available in adjoining rooms. The rental fee includes use of spaces tailored to your event needs, room setup and clean up, club tables and chairs, white or black linens, silverware, china, glassware, and votive candles.

The non-refundable rental fee secures your desired event date.

Large Dinner / Reception ... \$250

Monday - Thursday for 3 hours (more than 50 guests)

Small Dinner / Reception ... \$100

Monday - Thursday for 3 hours (less than 50 guests)

Luncheon or Breakfast ... \$50

Monday - Thursday for 2 hours

Additional event time may be arranged in advance for \$100 per hour.

A fee of \$250 per hour will be charged for events that extend past the agreed upon end time.

A food & beverage minimum may apply for events scheduled to begin outside of our normal operating hours of Monday - Tuesday 9am - 5pm; Wednesday - Friday 9am - 9pm; Saturday 5pm-9pm. Rental fees may not be applied to food and beverage minimums or charges. The club reserves the right to rent unused spaces to additional parties at our discretion.

Payment Policies

String & Splinter members may charge all fees and food/beverage purchases to their account.

Non-members must adhere to the following payment structure:

- ⇒ Non-refundable deposit of full rental fee required to reserve preferred date
- ⇒ 50% food deposit due upon selection of menu (typically 30 days prior to event)
- ⇒ Balance of food deposit due when submitting final headcount 72-hours prior to event
- ⇒ Final balance of beverages, tax, gratuity, and all other charges due within 5 business days post-event

Payments must be made by cash or personal/certified check. Credit card payments require a \$50 processing fee per transaction.

The String & Splinter reserves the right to adjust the payment structure for non-members at management's discretion including, but not limited to, requiring full payment for goods and services prior to the event.

Additional Policies:

The String and Splinter reserves the right to approve all outside **vendors** for an event hosted at the club. You may be asked to provide us with contact information, time of delivery/pickup, or other vendor information. Please advise us of your intentions to **decorate** the spaces for your event. Use of confetti, rice, or birdseed is not permitted and will result in a \$250 cleaning fee if used.

Guest **parking** is available in the lot at the corner of Lindsay St & High Ave and, if not used for an event, in the brick courtyard. Overflow and valet parking may be arranged with club assistance and may require additional fees. All guests attending an event must enter through the front lobby. The club provides an off-duty police officer as added **security** for evening events (6pm until close).

The String & Splinter does not assume **responsibility** for any damage or loss to items stored or displayed on club property, including vehicles. The event host is responsible for the full cost of any damage to club property caused by themselves or their guests.
